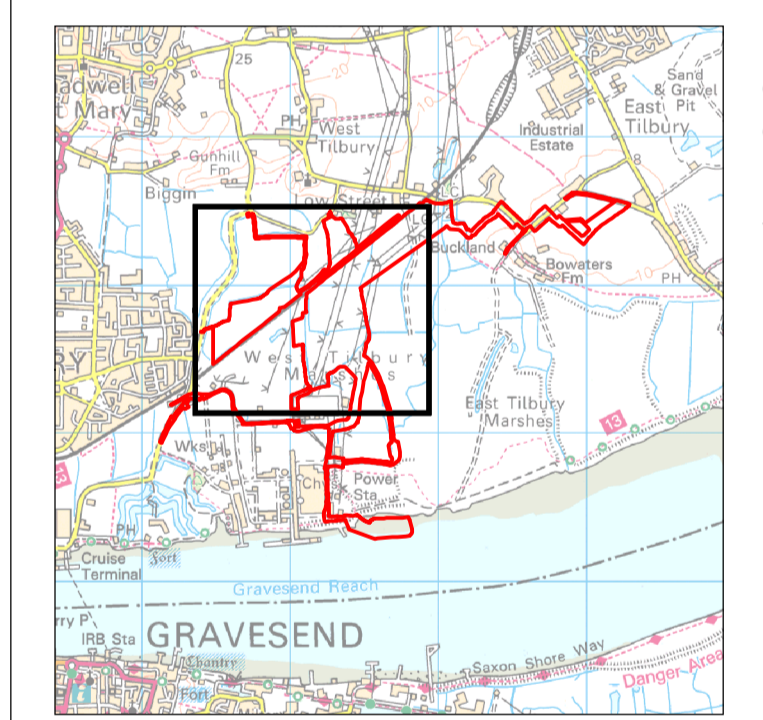
Thurrock Flexible Generation Plant Access, Rights of Way and Traffic Regulation Plans Index Sheet



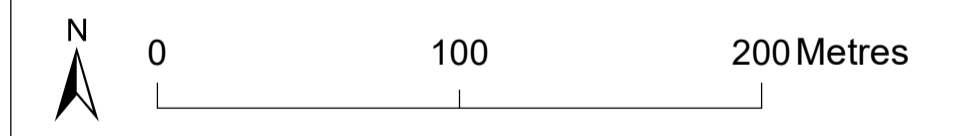
